## **Securing Your Booking**

- A 50% non-refundable deposit must be paid in advance to secure your booking.

## **COVID-19 Requirements**

- Hire of the Studio is regarded as a private hire venue

   which still succumbs to capacity restrictions. Under
   QLD Government regulations, if any persons attending are unvaccinated, a maximum of 20 people are allowed in the studio.
- All attendees must provide contact information, proof of COVID-19 vaccination or evidence of medical contraindication by using the Check In Qld app or another method of record keeping before entering the establishment.
- VERAS reserves the right to check vaccination status of any persons on the premises.

#### **Behaviour On Premises**

The Hirer **must not**, and must take active steps to ensure that none of the Hirer's associates, do any of the following during the booking period:

- Damage or attempt to damage any part of the Studio or its installations, fittings, or fixtures.
- Interfere with or alter any of the equipment, electrical, security, lighting, or sound systems in the Studio.
- Invite or permit into the Studio more than the expected number of guests specified in the Hire Form.
- Cause any nuisance to neighbours or other users of the building.
- Bring into the Studio any flammable materials, or light or maintain a naked flame.
- Smoke anywhere inside the Studio.
- Consume food/drink in the studio. Water is allowed.
- Do, say or display anything defamatory, offensive or of a pornographic nature.

We do not tolerate any aggression directed towards our staff and have a right to refuse service in this instance.

### **Cancellations**

- Cancellations made within 24 hours of the Date of Hire will result in the non-refundable 50% deposit fee.
- Cancellations made over 24hrs prior to the Date of Hire will result in a full refund.
